1. Open section of meeting at which members of the public can speak

Congestion at bottom of Broad Street near the junction with the Coventry Road was brought to the attention of the Council. Parking on both sides of the road together with parking on pavements obstructing pedestrians is causing a problem when vehicles attempt to negotiate the corner. It was agreed to bring it to the attention of the WCC Councillor to ask for a site meeting to discuss ways of easing the problem.

6. News and views from RBC and WCC Councillors

6.1 Rugby Borough Council is scheduled to have an 8% reduction in the grant from central government. RBC Councillors are to investigate this apparent anomaly.

6.2 RBC and WCC are to set a 0% precept, as are many Parish Councils in the area except where exceptional costs are anticipated.

6.3 The A528 road between Bretford and Brandon will be closed for 20 weeks for gas main repairs, with traffic diverted back to Coventry and through Brinklow

6.4 The possible installation of "gateways" to slow traffic on the Lutterworth Road and Coventry Road will be discussed at the WCC meeting in February. The new crossing to replace the refuge on Coventry Road is still due to be installed.

9.3 Cllr Tew attended a meeting of the Royal British Legion. They plan a "Poppy Party" on 12th June 2011 to celebrate 90 years since the poppy was adopted as a symbol. A number of organisations will be involved. Councillors agreed to support the event but request more information when it is available. **Action CT**

The Royal British Legion wish to erect a war memorial on The Crescent near to the church or on adjacent land. More information is required regarding the style of the memorial, and the cost. **Action CT,CT**
