- 9.3.1. BFC rent review. £462 for 2018 year was agreed by all Cllrs.

- **9.3.3** Drainage and clearance of ditches. To be investigated, along with hedging and fencing to the west perimeter, will be investigated and recommendations made to BPC for agreement. **Action: EF, JR.**
- **9.4.** Teenage shelter. There was some discussion over provision of a shelter on the playing field. The Clerk advised extensive consultation with houses neighbouring the field as this project had been mooted twice in the past but did not proceed due to hostility of those consulted.

**9.4.** Brinklow Castle. There is an ongoing study (WCC) to identify the diversity of flora and fauna on the site; a report will be submitted to BPC.

Also plans for the wild flower meadow on the rear field are ongoing.

**Post meeting note.** Warwickshire wildlife have received Lottery funding for bank clearance of scrub, harrowing and purchase of wild flower seeds. There is to be a family picnic and seed sowing event open to all.

- **9.5.** Neighbourhood Plan. Questionnaire to be circulated late summer.
- **10.** Tennis court refurbishment. The pressure wash and moss clearance are complete and work is ongoing to complete the project. The Lenghtsmen are to refurbish the bench with a considerable cost saving over using a contractor.
- **11. Adoption of Standing Orders.** Previously circulated to all; the Orders were unanimously adopted at the meeting.

**14. Lengthsmen Scheme.** Outlined to the meeting. Details, and a call for further volunteers, will be posted on the website. There was a formal request, to BPC, to fund the purchase of equipment and incidental expenses to support the scheme. This was approved unanimously by the meeting.

There was a unanimous vote of thanks to Cllr Reid (scheme leader) and all volunteers for their inputs thus far.
